I realize that I am subject to injury from these activities and that no form of pre-planning can remove all the danger to which I am exposing myself to. I acknowledge that Big Bend Rodeo Bible Camp is strongly recommending wearing a protective, ASTM, SEI certified riding helmet at all times when handling or riding on the grounds for the duration at camp. I also acknowledge that the helmet could prevent permanent brain damage or death in the event of an accident. If I refuse to wear a helmet, and by going against BBJrRBC's recommendations I hereby acknowledge that BBJrRBC will not be held liable or responsible for any accident or injury to person, property or horse.

I, the undersigned, am the duly authorized parent or guardian of the minor child, who is listed below.
